Sanction is accorded to the release of Rs. **200.00 lacs ( Rupees Two Hundred lacs only) with the break-up of Rs. 100.00 lacs each in favour of Superintending Engineer Drainage Circle SMC and Superintending Engineer Drainage Circle JMC** under Capex Budget 2015-16 of Drainage Sector ( capital component) for its further placement at the disposal of concerned Executive Engineers of Drainage Divisions to be utilized on clearance of workdone liabilities on account of works actually executed on ground during 2015-16.

The release & subsequent utilization of funds is subject to the following conditions that

- (i) **The funds shall be placed at the disposal of subordinate executing agencies within 2 days from the issuance of the order and copy endorsed to the Administrative Department .**
- (ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iv) the funds shall be utilized on the approved schemes/works only;
- (v) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vii) the funds so released shall not be available for any re-appropriation/diversion;
- (viii) the expenditure shall commensurate with the physical progress achieved;

- (ix) all video graphic/photographic evidence of works both shall be maintained;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
- (xii) **The concerned Superintending Engineers of both the Drainage Circles shall ensure the submission of Detailed Project Reports/Works Programmes in respect of ongoing drainage works and for the un-represented areas of the City for inclusion in State Level Implementation Plan under AMRUT for approval and funding.**
