Subject: - Release of funds of Capex Budget 2017-18 under Urban Development Sector.

Sanction is hereby accorded to the release of funds to the tune of **Rs. 3.00 Lacs (Rupees Three Lakh)** only in favour of **Director, Urban Local Bodies Jammu** under State Capex Budget 2017-18 of Urban Development Sector to be utilized for execution of emergent nature work viz; "Construction of Lane/Drain in W. No. 2, Govt. Middle School Bari Brahamana upto Raghunath Temple" during current financial year 2017-18.

The release & subsequent utilization of funds is subject to the following conditions that;

- (i) the funds shall be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance if the Govt. order and copy endorsed to the Administrative Department
- (ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iii) the funds shall not be utilized on clearance of any past liability, repair, renovation and maintenance work and there shall be no expenditure on Revenue or Revenue like items;
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (v) the funds shall be utilized on specified works only and no other scheme shall be taken up without the approval of the competent authority;
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
- (vii) the funds so released shall not be available for any re-appropriation/diversion;
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) all video graphic/photographic evidence of works both shall be maintained;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
