Subject:- Repatriation of Mr Abdul Rashid Wani, Junior Engineer, UEED to his parent Department. Viz. Public health & Engineering Department.

Whereas , Mr Abudl Rashid Wani Junior Engineer was posted in Urban Environmental Engineering Department vide Govt. Order No. 79-PW(HYD) of 2014 dated 22-02-2014 .

Whereas, Vide Govt. Order No. 186-HUD of 2014 dated 09-06-2014 , Mr. Abdul Rashid Wani, Junior Engineer was repatriated to his parent department viz Public Works Department.

Whereas, Mr. Abdul Rashid Wani,, Junior Engineer aggrieved by this, approached the Hon'ble high Court through the medium of Writ Petition No. 1641/2014 , CMA No. 2162/2014 titled Abdul Rashid Wani V/S States and others and obtained following orders.

"Meanwhile as and interim subject to objections and till next date before the bench, repatriation order dated 04-06-2014 supra be not implemented "

Whereas, the department has received a complaint against Mr. Abdul Rashid Wani, Junior Engineer, UEED Jammu from his two wives namely Mrs. Shabnam Wani and Jabeen Wani requesting for departmental action against him for Marrying four times during the life time of previous wives without formal divorce.

Whereas, vide Govt. Order No. 183-HUD of 2015 dated 30-07-2015, Mrs Anuradha Rani , Special Secretary to Government, H&UDD was appointed as Inquiry Officer to enquire into the allegations leveled against the official regarding solemnizing of more than one marriage.

Whereas, the Inquiry Officer has conducted detail enquiry and has submitted that as per the available records and verbal statements of various Officers/ Officials of Urban Environmental Engineering Department, prima facie established that the work and conduct of the accused official namely Mr. Abdul Rashid Wani, Junior Engineer has always remained under cloud during his deputation period in J&K Urban Environmental Engineering Department. Besides the allegations regarding solemnizing bigamous marriage/S have been prima facie establish. The enquiry officer has recommended to immediately repatriate Mr. Abdul Rashid Wani, Junior Engineer from J&K Urban Environmental Engineering Department.

Now, in compliance to order dated 24.06.2015 passed in Writ Petition No. 1641/2014, CMA No. 2162/2014 titled Abdul Rashid Wani V/S States and others the Government Order No 186-HUD of 2014 dated 04.06.2014 issued by the Department is hereby rescinded.
