Sanction is accorded to the release of Rs. **5.00 Crore** (Rupees Five Crore only) **in favour of Director Urban Local Bodies, Kashmir** under Capex Budget 2015-16 of Urban Development Sector **to be utilized for re-starting the work on Construction of Shopping Mall at Anantnag during year 2015-16 .**

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (iv) the execution of the work shall be carried out only after completing all codal procedures including Administrative Approval and Technical sanction from Competent Authority;
- (v) the implementing agency shall ensure that there is no overlapping of funds from any other source such as SDRF, State, District Plan, CSS, Flagship Programme or any other source.
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained.

- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority and the work is completed within the approved cost only.


