Subject: -Release of funds as additional Central Share for implementation of IHSDP under JNNURM (revalidated) during 2015-16.

Government Order No: - 244 -HUD of 2015

Dated: - 27 - 10- 2015

Sanction is hereby accorded to release of revalidated amount of Rs.1114.19 lacs (Rupees Eleven Crores, Fourteen Lacs and Nineteen Thousand) only along with advance drawl and placement of the same at the disposal of Chief Executive Officer J&K State Urban Infrastructure Development Agency (J&K SUIDA) under Integrated Housing & Slum Development Programme (JNNURM)- Capital Assets as additional central assistance for its utilization in 09 number of approved IHSDP Towns to the extent shown against each Town in enclosed Annexure "A".

The Director Finance H&UDD shall draw the funds in advance through WDC bill and credit the same in the official Saving Bank Account No:-18239 favouring CEO,J&K SUIDA.

However, the release of funds is subject to the completion of the following condition:-

- i. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities.
- ii. The CEO SUIDA shall transfer the funds to concerned implementing agencies within ten days as per the financial pattern given in guidelines of G.O.I for the programme under IHSDP and for the specific purpose for which funds stands released.
- iii. The funds shall be utilized for execution of the scheme strictly as per the original approved comments and according to G.O.I prescribed guidelines.
- iv. The agency shall release the funds for the components as per DPR's approved by G.O.I.
- v. The agency shall submit the utilization certificate by or before 01.04.2016 to the Ministry of Urban Development, G.O.I with a copy to this department.

- vi. The Director Finance Housing & Urban Development Department shall vouchsafe the utilization of funds as per codal procedure/G.O.I guidelines.
- vii. The executing agency shall ensure to furnish the interest earned on these funds for whatever period these remain un-utilized for remittance of the interest amount to the state exchequer.

The expenditure on this account shall be debited as per following classification for proper accounting:-


