Sanction is hereby accorded to release of funds amounting to Rs.37.25 lacs (Rupees Thirty Seven Lacs and Twenty Five Thousand) only in favour of Director Urban Local Bodies Jammu/Kashmir under the Housing sector for Construction of Community Halls under Capex budget of 2015-16 (Capital Component). The funds so released shall be strictly utilized for the "Construction of Community/Town Halls to the extent shown against each indicated at Annexure "A" to this government order.

**However, the release of funds is subject to the completion of the following condition;-**

- i. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities;
- ii. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the competent Authority;
- iii. The executing agency shall ensure that there is no overlapping of funds for the works being executed;
- iv. The executing agency shall furnish physical/financial progress report to this department by or before 5th of every month;
- v. The funds so released shall not be available for any re-appropriation/diversion;
- vi. The Red Accounts is expedited to the Audit Office without any delay;

The expenditure on this account shall be debited as per following classification for proper accounting:-

- Demand No: 19
- Major Head: 4216-Capital outlay on Housing.
- Sub-major Head: 01 Residential Buildings.
- Min or Head: 700-Other Housings.
- Group Head: 011-State Plan SPA.
- Sub-Head: 0893 Other Housing Schemes.
