Sanction is hereby accorded to release of funds amounting to Rs.16.00 lacs (Rupees Sixteen Lacs) only in favour of Director Urban Local Bodies Kashmir under the scheme "Urban Development Sector" (Clearance of Liability) Capex Budget 2015-16 (Capital Components). The funds so released shall be strictly utilized for "construction of Rasool Mir Memorial Hall at Municipal Committee Dooru-Verinag.

However, the release of funds is subject to the completion of the following condition:-

- i. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities;
- ii. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the competent Authority;
- iii. The executing agency shall ensure that there is no overlapping of funds for the works being executed;
- iv. The executing agency shall furnish physical/financial progress report to this department by or before 5th of every month;
- v. The funds so released shall not be available for any re-appropriation/diversion;
- vi. The Red Accounts is expedited to the Audit Office without any delay;


