Sanction is accorded to the release of Rs. **25.00 lacs ( Rupees Twenty Five lacs) only in favour of Superintending Engineer Drainage Circle SMC** under Capex Budget 2015-16 Emergent Public Demands of Drainage Sector ( capital component) for its utilization to the execution of Drainage Scheme at Mominabad Tengpora during 2015-16.

The release & subsequent utilization of funds is subject to the following conditions that

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the approved schemes/works only;
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.


