Sanction is accorded to the release of funds to the tune of **Rs. 10.00 Lacs (Rupees Ten Lakh only)** in favour of **Director Urban Local Bodies Jammu** of State Capex Budget 2018-19 under the scheme "Emergent Public Demands" for its further placement at the disposal of concerned Executive Engineers Town Drainage Jammu to be utilized for clearance of liability for "Construction of Nallah at Mominabad Jalalabad Sunjwan" during current financial year.

The release & subsequent utilization of funds is subject to the following conditions that;

- (i) the funds shall be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance of the Govt. order and copy endorsed to the Administrative Department;
- (ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iv) the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.




