Sanction is accorded to the release of funds to the tune of Rs. **24.50 lacs (Rupees twenty four lacs and fifty thousand only)** in favour of Director local bodies Jammu under scheme (**Clearance of work done liability**) of urban development sector- capex Budget 2015- to be utilized for clearance of work done claim of civic work repair/ renovation of road by way of black topping in main bazaar/ Bus-stand at Municipal Committee Katra.

The release & subsequent utilization of funds is subject to the following conditions that:-

- 1 The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- 2 The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- 3 The funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- 4 The funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work.
- 5 The implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- 6 The funds so released shall not be available for any re-appropriation/diversion;
- 7 The expenditure shall commensurate with the physical progress achieved;
- 8 All video graphic/photographic evidence of works both shall be maintained.
- 9 The physical and financial progress report shall be furnished to the Admn. Deptt. Well in time.
