**Government Order No: - 291 - HUD of 2015**  
**Dated 31 - 12-2015**

Sanction is accorded to the release of Rs. 100.00 lacs ( Rupees One Hundred lacs only) in favour of Director Urban Local Bodies, Jammu under the scheme " Restoration of Damages Assets" of Capex Budget 2015-16 of Urban Development Sector ( capital component) for its further placement at the disposal Executive Engineer Town Drainage Division, Jammu to be utilized on restoration of damaged assets caused due to flashfloods of September 2014 not covered under Flood Restoration Programme to the extent of amount shown against each in the Annexure -A to this Govt. Order.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) **The funds shall be placed at the disposal of subordinate executing agencies within 2 days from the issuance of the order and copy endorsed to the Administrative Department .**
- (ii) **the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme or any other source.**
- (iii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (v) the funds shall be utilized on the approved schemes/works only;
- (vi) the funds shall not be utilized for repair renovation & Maintenance work;
- (vii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (viii) the funds so released shall not be available for any re-appropriation/diversion;

- (ix) the expenditure shall commensurate with the physical progress achieved;
- (x) all video graphic/photographic evidence of works both shall be maintained;
- (xi) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.


