The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, HFA(U) bearing Account No. **0110010200000870** maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for further transfer to the Nodal Agency implementing component of PMAY-HFA(U).

However, further release of funds shall be subject to fulfillment of the following conditions by the Nodal Agency:-

1. The funds shall be utilized for the purpose these have been released;
2. No diversion/re-appropriation of funds so released is allowed;
3. The released funds does not confer the sanction to incur the expenditure which shall be booked after observing all codal formalities;

4. The funds shall be utilized for implementation of scheme strictly as per originally approved components and according to Govt. of India's prescribed guidelines;
5. The Geo-tagging funds shall be utilized after observing terms & conditions stipulated in the guidelines, CSMC directions and instructions issued by the Ministry of Housing & Urban Affairs, Govt. Of India.
6. The Progress report about the scheme, in terms of physical and financial progress achieved during the current year and upto date cumulative expenditure and physical achievement be sent to this Department regularly;
7. Nodal Agency shall send Utilization Certificates of the funds released as early as possible and definitely well before 31.3.2019 to GOI, with a copy to the Finance Department.
8. The Nodal Agency shall vouchsafe the utilization of funds as per codal procedure/Govt. of India's guidelines.
