In the interest of administration, sanction is hereby accorded to the placement of the following officers of the Architects Organization, J&K on the posts noted against each in their own pay and grade as a stop gap arrangement:-

2. Mr. Harinder Arora, I/c Divisional Architect as I/c Senior Architect.

Consequent upon the above the following transfers and postings are hereby ordered with immediate effect:-

- I. Ms. Anita Samyal, I/c Senior Architect is posted as I/c Chief Architect, J&K Architects Organisation.
- II. Mr. Harinder Arora, I/c Divisional Architect is posted as I/c Senior Architect, Jammu in place of Ms. Anita Samyal.

The above arrangement shall be subject to following conditions:-

- i. They shall work in their own pay and grade purely on temporary basis against available vacancies till the posts are filled up under rules by the DPC/PSC.
- ii. Their temporary arrangement shall not confer any preferential right on them to claim promotion on substantive basis which shall be considered by the PSC/DPC strictly as per rules.
- iii. The arrangement will be without prejudice to the seniority and superior claim of others, if any and subject to the outcome of the writ petition(s), if any, pending before the competent Court of Law.

It is further ordered that Shri Bharat Bhushan Sharma, Building Officer, Jammu Municipal Corporation, shall hold the charge of the post of Senior Town Planner in addition to his own duties till further orders.
