Sanction is hereby accorded to the release of **Rs.24.16 lacs (Rupees Twenty Four lacs & Sixteen Thousand)** only as 1st. Installment of central grant for establishment of SLTC under PMAY(U)-HFA(U) and reimbursement claim by the State towards salary of specialists engaged under CLTC for the year 2016-17 for its utilization during current financial year 2017-18 and its placement at the disposal of **Mission Director PMAY- Housing For All (Urban).**

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, HFA(U) bearing Account No. 0110010200000870 maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for further transfer to the Nodal Agency implementing component of PMAY-HFA(U).

However, further release of funds shall be subject to fulfilment of the following conditions by the Nodal Agency:-

1. The funds shall be utilized for the purpose these have been released;
2. No diversion/re-appropriation of funds so released is allowed;
3. The released funds does not confer the sanction to incur the expenditure which shall be booked after observing all codal formalities;
4. The funds shall be utilized for implementation of scheme strictly as per originally approved components and according to Govt. of India's prescribed guidelines;

5. The Progress report about the scheme, in terms of physical and financial progress achieved during the current year and upto date cumulative expenditure and physical achievement be sent to this Department regularly;
6. Nodal Agency shall send Utilization Certificates of the funds released as early as possible and definitely well before 31.3.2018 to GOI, with a copy to the Finance Department.
7. The Nodal Agency shall vouchsafe the utilization of funds as per codal procedure/Govt. of India's guidelines.
