Sanction is accorded to the release of funds to the tune of Rs. **875.00 Lacs (Eight Crore Seventy Five Lacs) only** under Capex budget 2016-17 as "Bridge Finance" under Prime Minister's Development Package (PMDP) for permanent restoration of damaged infrastructure, in favour of **Superintending Engineer Drainage Circle SMC, Srinagar** for its further placement at the disposal of **concerned Executive Engineer**, for utilization against authorized works, as per the scheme/division wise breakup given in the **Annexure "A"** to this Government Order.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. The funds shall be placed at the disposal of subordinate executive agencies within two days from the issuance of the order;
- ii. The executing agency shall ensure that payment shall be made against only those works which have been authorized by this department and certificate to this effect that the work has been authorized by the competent authority shall be given by the concerned HOD;
- iii. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities;
- iv. The funds shall not be utilized on clearance of any past liability, repair, renovation and maintenance work;
- v. The funds shall be utilized on those components of the scheme only which have been technically sanctioned and administratively approved by the competent authority;
- vi. The procurement of the machinery if any shall be made through competitive bidding from reputed company;
- vii. The executing agency shall ensure that the payment to the contractor shall be made only after the physical verification of the works by the committee, constituted for the purpose;
- viii. The executing agency shall ensure that the works/schemes authorized by this department have not been accommodated under any other state/ central sponsored scheme in the past and moreover same have also not been proposed in current years Capex Budget/ Works Programme. Besides the flood restoration works under the Prime

- Minister's Development Package-2015 (PMDP) must have been reflected in the details submitted under the Flood Damages Restoration Programme. Any duplicity on this account shall be personnel responsibility of the concerned HOD/DDO;
- ix. The expenditure shall commensurate with the physical progress achieved and complete videography/photography of the works at pre-execution, during and post execution stages have been maintained against each work;
- x. No expenditure shall be incurred against revised cost which has not been approved by the competent authority;
