Sanction is hereby accorded to the release of **Rs. 1.55 Lacs (Rupees one Lac and Fifty Five Thousand)** only along with advance drawl in favour of Commissioner Jammu Municipal Corporation under the scheme "**Emergent Public Demands**" of Urban Development Sector – Capex Budget 2015-16 to be utilized for construction of lane at Bilal Colony, Channi Rama, Jammu during the current financial year 2015-16.

The release & subsequent utilization of funds is subject to the following conditions that: -

- (i) the funds shall be placed at the disposal of subordinate executive agencies within seven days from the issuance of the order and copy endorsed to the Administrative Department;
- (ii) the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/BADP or any other source;
- (iii) the funds so released shall be utilized for proper purpose and not to be benefited to any individual;
- (iv) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (v) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;
- (viii) the expenditure shall commensurate with the physical progress achieved;

- (ix) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;


