Subject:- Restoration of administrative/financial/supervisory powers to Chief Executive Officers, JUDA/UDAK in respect of DUDAs.

Consequent upon the decision taken in the 6<sup>th</sup> Meeting of the Governing Body, J&K State Urban Development Authority held under the Chairmanship of Hon'ble Deputy Chief Minister (Minister I/C Housing & Urban Development Department / Chairman, J&K State Urban Development Authority), sanction is hereby accorded to the :-

- (i) Conferment of administrative/supervisory powers to the Chief Executive Officers, Jammu Urban Development Agency (JUDA) and Urban Development Agency Kashmir (UDAK) at Provincial level in respect of all District Urban Development Agencies (DUDAs) of Jammu and Kashmir Provinces respectively with a view to enlarge their jurisdiction at Provincial Level;
- (ii) Designation of the CEOs, JUDA/UDAK as CEO, JUDA, Jammu Province and CEO, UDAK, Kashmir Province;
- (iii) Fixation of town wise targets strictly as per potential survey under various components of Urban Poverty Elevation Schemes under implementation with the department. The SUDA shall henceforth convey target to the CEO JUDA/UDAK, who shall undertake further distribution of the same amongst the DUDAs to formulate Annual Action Plan.
