Sanction is hereby accorded to the release of **Rs. 56.25 Lacs (Rupees Fifty Six Lacs and Twenty Five Thousand)** only in favour of Managing Director J&K Housing Board of Housing sector – Capex Budget 2015-16 to be utilized for ongoing scheme “Upg. of civic system in existing colonies” during the current financial year 2015-16.

The Director Finance H&UDD shall draw the funds in advance through WDC bill and place the same at the disposal of Managing Director J&K Housing Board.

The release & subsequent utilization of funds is subject to the following conditions that: -

- (i) the funds shall be placed at the disposal of subordinate executive agencies within seven days from the issuance of the order and copy endorsed to the Administrative Department;
- (ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;
- (v) the Utilization Certificate for the released amount shall be submitted for release of 2nd installment;
- (vi) all the UCs/Red Accounts of previous advance drawal have been rendered to the concerned quarter;
- (vii) the Red Accounts is expedited to the audit office without any delay
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
