In continuation to Govt. Order No. 206-HUD of 2015 dated 07.09.2015, sanction is hereby accorded to the release of funds amounting to **Rs. 138.25 Lacs (Rupees One Hundred Thirty Eight Lacs and Twenty Five Thousand)** only in favour of **Chief Engineer J&K UEED, Srinagar** under Sewerage Sector to be utilized on approved ongoing schemes/works of the current F.Y 2015-16 as per following breakup: -

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) *the funds shall be placed at the disposal of subordinate executing agencies within 7 days from the issuance of the order and copy endorsed to the Administrative Department;*
- (ii) *the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as, SDRF, District Plan, CSS, BADP, CDF, MPLADs etc.;*

- (iii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iv) the funds shall be utilized on those components of the schemes only which have been Technically sanctioned and Administratively approved by the Competent Authority;
- (v) the funds shall be utilized on the ongoing schemes/works only.
- (vi) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;
- (vii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (viii) the funds so released shall not be available for any re-appropriation/diversion;
- (ix) the expenditure shall commensurate with the physical progress achieved;
- (x) that all video graphic/photographic evidence of works both shall be maintained;
- (xi) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;


