Sanction is hereby accorded to the release of **Rs. 74.72 Lacs (Rupees Seventy Four Lacs & Seventy Two Thousand)** only in favour of **Director Urban Local Bodies, Jammu** out of the available funds under Capex Budget 2016-17 to be utilized for execution of different developmental works during the year 2016-17 to the extent of amount shown against each Municipal Committee's to be prioritized in consultation with the public representatives of the areas. The Municipality wise details of the funds are Annexed at **Annexure "A"**.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the execution of the works be taken up after seeking formal approval of the works so identified/prioritized from the Administrative Department;
- (iii) the funds shall be utilized on those components of the schemes only which have been Technically sanctioned and Administratively approved by the Competent Authority;
- (iv) the implementing agency/s shall ensure that the work should be executed on e-tendering mode;
- (v) the funds shall be utilized on the approved schemes/works only and no new scheme shall be taken up without the approval of the Competent Authority;
- (vi) the funds shall not be utilized on clearance of past liability, repair, renovation and Maintenance work and the works should not have been executed during last 5 years;
- (vii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source Such as SDRF/State Plan/District Plan /CSS/Flag Ship Programme or any other source;
- (viii) the funds so released shall not be available for any re-appropriation/diversion;
- (ix) the expenditure shall commensurate with the physical progress achieved;
- (x) all video graphic/photographic evidence of works both shall be maintained;
- (xi) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

- (xii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;


