Consequent upon release of additional funds by the Planning Development and Monitoring Department vide Govt. Order No. referred to above, sanction is hereby accorded to the release of **Rs. 250.00 Lacs (Rupees Two Hundred Fifty Lacs)** only in favour of **Chief Engineer, PWD (R&B), Kashmir** for its further placement at the disposal of Managing Director, JKPCC under Urban Development Sector of Capex Budget 2016-17 to be utilized for **"Construction of Khankah Charar-i-Sharief (District Budgam)"** during the current financial year 2016-17.

The release & subsequent utilization of funds is subject to the following conditions that: -

- i. the funds shall be placed at the disposal of the MD, JKPCC within seven days from the issuance of the order and copy endorsed to the Administrative Department;
- ii. the expenditure should be booked only after observing all codal formalities, besides, adhering quality parameters;
- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iv. the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- v. the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- vi. the funds so released shall not be available for any re-appropriation/diversion;
- vii. the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;
- viii. the expenditure shall commensurate with the physical progress achieved.
- ix. the UCs for the released amount shall be submitted to the department for release of further funds;
- x. the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- xi. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;

- xii. that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
