Sanction is hereby accorded to release of funds amounting to Rs.666.04 Crores (Rupees Six Crores, Sixty Six Lacs and Four Thousand) only under Annual Plan 2014-15 in favour of Chief Executive Officer J&K SUIDA for meeting the state share required for the below mentioned schemes sanctioned under JNURM as per schematic break-up given here under:-

The Director Finance H&UDD shall draw the funds in advance from Treasury through WDC bill and place the same at the disposal of implementing agency i.e. CEO J&K SUIDA for further releases to implementing Agencies.

**However, the release of funds is subject to the completion of the following condition:-**

- i. The agency shall transfer the funds to the implementing agency immediately as per the financial pattern in the guidelines of Government of India for the programme under UIG and for the specific purpose for which it has been released.
- ii. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the competent Authority;
- iii. The executing agency shall ensure that there is no overlapping of funds for the works being executed;
- iv. The CEO SUIDA shall ensure that the released state share be restricted to the sanctioned/ committed state share against each project of the scheme.
- v. The executing agency shall furnish physical/financial progress report to this department by or before 5th of every month;
- vi. The funds so released shall not be available for any re-appropriation/diversion;

- vii. The utilization certificate for the released amount shall be s  
to this department by or before March 2015;
- viii. The Director Finance of the department shall vouchsafe the uti  
of funds as per codal procedure/ guidelines;

The expenditure on this account shall be debited as per follo  
classification for proper accounting:-

- Demand No: 19
- Major Head: 4217-Capital outlay on Urban Developmen
- Minor Head: 800-Other Expenditure.
- Group Head: 0011-State Plan Normal.


