Subject:- Release of funds under Drainage Sector (JMC) - Annual Plan 2014-15.
Ref:- Planning & Dev. Department's authorization conveyed vide Govt. Order No. 45-PD of 2015 dated 13.3.2015.

Sanction is accorded to the release of Rs. **180.00 lacs (Rupees One Hundred Eighty lacs only) in favour of Superintending Engineer, S&D West Jammu JMC** totaling 100% of the Annual Plan allocation under Drainage Sector (capital component) for its further placement at the disposal of Executive Engineer **S&D West Jammu to be utilized on approved ongoing schemes/works only during 2014-15**, as per the schematic breakup detailed in Annexure-A to this Govt. Order.

The release & subsequent utilization of funds is subject to the following conditions that

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only;
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (x) the implementing agency shall follow up the procedural mechanism of Web CAS -MIS System.
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.






