Sanction is accorded to the release of funds to the tune of Rs. **250.00 lacs** (Rupees Two Hundred Fifty lacs only) with the break-up of Rs. 125.00 lacs each in favour of Director Urban Local Bodies Kashmir and Director Urban Local Bodies Jammu totaling **100%** of the Annual Plan 2014-15 allocation of IDMT scheme of Urban Development Sector **to be utilized on approved works only during year 2014-15.**

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) **the funds shall be utilized on the ongoing schemes/works only and no funds shall be utilized for the schemes/works which have not been approved by the Administrative Department.**
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained.
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (x) the implementing agency shall follow up the procedural mech. Of CAS - MIS System;

- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
