Sanction is accorded to the release of Rs 25.40 lacs (Rupees Twenty Five lacs & Forty Thousand only) in favour of **Superintending Engineer Drainage Circle SMC Srinagar** under the scheme of "Clearance of Liabilities" of Urban Development Sector - Capex Budget 2015-16 for further placement of the same at the disposal of Executive Engineer City Drainage Civil SMC, to be utilized for clearance of liabilities of approved works during 2015-16 as detailed in Annexure-A to this Govt. Order:-

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the funds shall be placed at the disposal of subordinate executing agencies within 3 days from the issuance of the order and copy endorsed to the Administrative Department.
- (ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iii) the funds shall be utilized on those components of the scheme only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any re-appropriation /diversion;

- (vi) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained.
- (vii) the UCs for the released amount shall be submitted well in time ;
- (viii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
