6. **the expenditure shall commensurate with the physical progress achieved.**
7. All video /photographic evidence of works shall be maintained.

8. the physical and financial progress report shall be furnished to the Administrative Department well in time
9. the implementing agency shall follow up the procedural mechanism of CAS – MIS System.
