Sanction is hereby accorded to the release of funds amounting to **Rs. 6.00 Lakh (Rupees Six Lakh)** only in favour of **Director, Urban Local Bodies Jammu** under Special Task Force for its utilization under the approved scheme viz; "Construction of Modern Slaughter House near Sultanpora Bridge Baderwah" against the approved cost of Rs. 200.00 Lakh during current financial year.

The release & subsequent utilization of funds is subject to the following conditions that;

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the no new work outside the approved action plan/DPR shall be taken up for execution without the approval of the competent authority;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
- (v) the funds so released shall not be available for any re-appropriation/diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved;
- (vii) all video graphic/photographic evidence of works both shall be maintained;
- (viii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (ix) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
