Sanction is hereby accorded to the release of funds amounting to Rs.25.00 lacs (Rupees Twenty Five Lacs) only in favour of Vice Chairman Srinagar Development Authority for Construction of Habitat Centre Bemina Srinagar under Urban Development Sector Annual Plan 2014-15. However, the funds so released shall be utilized strictly for the purpose these have been released.

The Director Finance H&UDD shall draw the funds in advance through WDC bill from Treasury and place the same at the disposal of Vice Chairman Srinagar Development Authority.

**However, the release of funds is subject to the completion of the following condition;-**

- i. The funds shall be utilized only those components of the schemes which have been technically sanctioned and administratively approved by the competent Authority as per the CAS-MIS format;
- ii. The executing agency shall ensure that there is no overlapping of funds for the works being executed;
- iii. The executing agency shall furnish physical/financial progress report to this department by or before 5th of every month;
- iv. The funds so released shall not be available for any re-appropriation/diversion;
- v. The utilization certificate for the released amount shall be submitted to this department at the end of March 2015;

- vi. The funds shall not be utilized on clearance of any past liability/repair/renovation & maintenance work.

**The expenditure on this account shall be debited as per following classification for proper accounting:-**

- Demand No: 19
- Major Head: 4217-Capital outlay on Urban Development.
- Minor Head: 800-Other Expenditure.
- Group Head: 0011-State Plan Normal.
- Sub-Head: 1297 Urban Development Sector
