The release & subsequent utilization of funds is subject to the following conditions that:-

- 1 the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- 2 the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- 3 that no new work outside the approved action plan shall be taken up for execution without the approval of the Competent Authority

- 4 the execution of works shall be taken strictly for the approved plan schemes and no liability shall be created ensuring financial discipline in the system, until specifically authorized by the Competent Authority;
- 5 the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities
- 6 the funds so released shall not be available for any re- appropriation /diversion; the expenditure shall be restricted within the funds released;
- 7 the expenditure shall commensurate with the physical progress achieved;
- 8 all codal formalities shall be adhered to while incurring the expenditure; all video graphic/photographic evidence of works both shall be maintained
- 9 The MPRs/QPRs shall be regularly furnished to the Adm. Department well in Time.
