Sanction is here by accorded to the release of funds to the tune of **Rs. 21.60 Lacs (Twenty One Lacs and Sixty Thousand only) along with Advance Drawl in favour of Managing Director, J&K Housing Board, Jammu** for establishment of State Level Technical Cell (SLTC) under Pradhan Mantri Awas Yojana-Housing for All (Urban) Mission, released by MoHUPA, GoI as grant in aid as 1<sup>st</sup> instalment of Central Assistance for its utilization during current financial year (2016-17).

The Director, Finance H&UDD shall draw the funds in advance from treasury through WDC bills and place the same at the disposal of MD, J&K Housing Board, Jammu immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. the Implementing Agency shall comply with the terms and conditions stipulated in the guidelines, CSMC directions and the instruction issued by the Ministry of HUPA, GoI;
- ii. financial norms approved by CSMC as well as adherence to scheme guidelines and submission of pending UCs under RAY, if any;
- iii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- iv. the nodal agency shall utilize the sanctioned grant for the purpose for which it is released and shall furnish physical and financial progress report every quarter;
- v. Transfer of funds to different entities may be made through PFMS as applicable; and where there is an element of case transfers to individual beneficiaries, the same be made through DBT mode, as applicable;
- vi. the implementing agency shall ensure that there is no overlapping of funds from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. etc;
- vii. the implementing agency shall transfer the funds as per the financial pattern in the guidelines of GOI for the programme under HFA and for the specific purpose for which it has been released;
- viii. the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GoI's prescribed guidelines;
- ix. the funds so released shall not be available for any re-appropriation/ diversion at any level;

- x. the Utilization Certificate along with Red Accounts for the released amount shall be submitted to the Administrative Department/Accountant General Office, Jammu within the stipulated time;
- xi. the State Nodal Officer of HFA shall strictly monitor the progress of the preparatory;
