Sanction is here by accorded to the release of funds to the tune of **Rs. 331.275** Lacs (Three Crore Thirty One Lacs Twenty Seven Thousand and Five Hundred only) along with Advance Drawl in favour of Mission Director, PMAY-Housing for All (Urban) for creation of Capital Assets under Pradhan Mantri Awas Yojana (PMAY) - Housing for All (Urban) Mission released by MoHUPA, GoI for two towns viz. Udhampur & Baramulla and demand survey of identified 50 towns as grant in aid as 1st instalment of Central Assistance under Plan Allocation (SCSP component) for the year 2016-17 with the following breakup: - **(Rs. in Lac)**

The Director, Finance H&UDD shall draw the funds in advance from treasury and credit to the official bank Account of Mission Director, AMRUT, maintained in the J&K Bank Moving Sectt. Branch bearing Account No. 0110040500000061 immediately.

- The release & subsequent utilization of funds is subject to the following conditions that:-
- the above release is only for the cities as mentioned above;
 - the Implementing Agency shall comply with the terms and conditions stipulated in the guidelines, CSMC directions and the instruction issued by the Ministry of HUPA, GoI;
 - the funds shall be released to the Consultant/Agency/Firm (engaged for the preparation of HFAPoA and conduct of Demand Survey) as per the payment schedule and after ensuring that terms and conditions laid down in the agreement signed with the Consultant/Agency/Firm shall be strictly followed;
 - the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
 - the implementing agency shall ensure that there is no overlapping of funds from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. etc;
 - the implementing agency shall transfer the funds as per the financial pattern in the guidelines of GOI for the programme under HFA and for the specific purpose for which it has been released;
 - the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GoI's prescribed guidelines;

- viii. the funds so released shall not be available for any re-appropriation/ diversion at any level;
- ix. the expenditure shall commensurate with the physical progress achieved;
- x. the Utilization Certificate along with Red Accounts for the released amount shall be submitted to the Administrative Department/Accountant General Office, Jammu within the stipulated time;
- xi. all video graphic/photographic evidence of works both shall be maintained.
- xii. the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- xiii. no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;
- xiv. the State Nodal Officer of HFA shall strictly monitor the progress of the preparatory;
