In continuation to Govt. Order No. 31-HUD of 2016 dated 29.01.2016, sanction is accorded to the release of **Rs 12.50 lacs (Rupees Twelve lacs Fifty Thousand only) i.e. Rs. 6.25 lacs each in favour of Director, Building Centre, Jammu (BCJ) and Director, Building Centre Srinagar (BCS under Capex Budget 2015-16 for the scheme "Building Centre" of Housing Sector to be utilized for approved Action Plan during 2015-16 .**

The Director Finance, H&UDD shall draw the funds in advance from Treasury through WDC Bills and place the same at the disposal of concerned Agencies immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the scheme only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any re- appropriation /diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained.
- (vii) the UCs for the released amount shall be submitted for release of further funds;

- (viii) the Director Finance of the Deptt. shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- (ix) all the UCs/Red Accounts of previous advance drawals shall be rendered to the concerned quarters;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time
- (xi) the Red Accounts is expected to the Audit Office without any delay.

This issue with the concurrence of advance drawal of funds conveyed by Director Finance vide his UO No. 22/DF/HUD/16 Dated 17.03.2016.


