GOVERNMENT ORDER NO. 98 -HUD OF 2015
D A T E D : 26 . 03. 2015

Whereas, Mr. Ghulam Mohi-ud-Din Mali, the then I/C Executive Officer, Municipal Committee, Kupwara was placed under suspension vide Govt. Order No. 03-HUD of 2014 dated 01.01.2014 for illegal engagements/ appointments in Municipal Committee, Kupwara vide Order No. MCK/Estt/213/344-45 dated 11.05.2013, MCK/Estt/2013/359-61 dated 13.05.201 and MCK/Estt/2013/1112-14 dated 14.10.2013 beyond his competence and jurisdiction;

Whereas, Mr. Iftikhar Ahmad Hakim, I/C Chief Town Planner, Town Planning Organization, Kashmir was appointed as Inquiry Officer to conduct enquiry into the alleged illegal appointments;

Whereas, the Director, Urban Local Bodies, Kashmir was also requested to serve a Charge Sheet in favour of the delinquent officer in terms of relevant CCA Rules of 1954 immediately;

Whereas, the Inquiry Officer has submitted its report vide his letter No. Enquiry-M.C-Kupwara/CTPK/14/01 dated 10.07.2014 and has recommended that the 50% amount to the 10(ten) illegal appointees should be recovered from the salary of Mr. Ghulam Mohi-ud-Din Mali, I/C Executive Officer, Municipal Committee, Fresal, then I/C Executive Officer, Municipal Committee, Kupwara in installments in terms of Rule 30(V) of the J&K CCA Rules, 1954 ensuring uniform punishment for similar nature of cases;

Whereas, the Director, Urban Local Bodies, Kashmir has recommended the reinstatement of Mr. Ghulam Mohi-ud-Din Mali, I/C Executive Officer on submission of his representation;

Whereas, the suspension case of the officer was placed before the Review Committee constituted vide Govt. Order No. 117-HUD of 2014 dated 27.03.2014 and the Committee in its meeting held on 22.07.2014 accepted the recommendations of the Inquiry Officer and decided that simultaneously the officer shall be reinstated and attached with Director, Urban Local Bodies, Kashmir who shall assign non-sensitive work to him;

Whereas, the I/C Executive Officer among others has been reinstated vide Government Order No. 22-HUD of 2014 dated 21.08.2014, however, the punishment as recommended by the Inquiry Officers was not accorded in terms of Rule 30(V) of J&K CCA Rules, 1954.

Now, as recommended by the Review Committee and Inquiry Officer, it is hereby ordered that an amount of Rs. 2,25,000/- paid to the Casual Labourers engaged by Mr. Ghulam Mohi-ud-Din Mali, the then I/C Executive Officer in Municipal Committee, Kupwara shall be recovered from him by the Directorate of Urban Local Bodies, Kashmir immediately, proportionately from his salary.
