- (iv) the funds so released shall not be available for any re-appropriation any diversion from one component to another component.
- (v) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained.
- (vi) the Utilization Certificates for the released amount shall be submitted well in time;
- (vii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
