Subject: Constitution of Fact Finding Committee.

Government Order No. 113 -JK(HUD) of 2021
Dated: 30-07-2021

Sanction is hereby accorded to the constitution of a Fact Finding Committee comprising the following officers to enquire into the appointment / promotions granted to Mr. Mohammad Ashraf Dar, Tax Inspector and other similarly circumstanced employees of Director of Urban Local Bodies, Kashmir from time to time:-

1. Vice Chairman, Srinagar Development Authority.
2. Financial Advisor & CAO, Srinagar Municipal Corporation.

It is further ordered that Deputy Director, Urban Local Bodies Kashmir shall assist the Committee.

The terms of reference of the Fact Finding Committee shall be as under:

- i. Look into the appointment / promotion granted to Mr. Mohammad Ashraf, Tax Inspector from time to time alongwith similarly situated cases referred to by the Hon'ble High Court in its Judgement dated 29.01.2018 of the Hon'ble High Court of J&K passed in SWP No. 1367/2012 titled Mohammad Ashraf vs State of J&K & Others read with Judgement dated 15.10.2018 in LPASW No. 138/2018.
- ii. Verify whether these appointment / promotions are in consonance with the rules.
- iii. Identify the officers/officials responsible for these appointment/promotions which has caused loss to the Government exchequer.
- iv. Pin-point the officers / officials responsible for having failed to apprise the Hon'ble High Court about the factual position of the case besides, contributing inordinate delay thereby impeding in availing all legal remedies including filing of SLP.

The Committee shall complete the inquiry and submit its report within one month from the date of issue of this order.
