The Director Finance, H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Commissioner SMC/JMC as per the break-up of funds shown in the above table. DULBJ/K shall further place the funds at the disposal of ULBs for incurring the expenditure under the scheme.

The release & subsequent utilization of funds is subject to the following conditions that: -

- i. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/BADP/Languishing (JKIDFC)/Flagship programme or any other source;
- iv. the funds are utilized strictly on the activities submitted to Adm. Deptt. vide above referred letters and no deviation of expenditure is permitted;
- v. the funds are not parked idle in the bank account;
- vi. the funds so released shall not be available for any re-appropriation/diversion;
- vii. the expenditure shall commensurate with the physical progress achieved;
- viii. the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- ix. that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;

- x. Utilization Certificate shall be submitted to Administrative Department within the stipulated time.
