
Government Order No. 170 -JK (HUD) of 2021

In exercise of powers vested under SO 15 of dated 09-01-2020 issued by Finance Department, sanction is hereby accorded to grant of Administrative Approval of the following schemes/works under Sewerage sector at estimated cost shown against each scheme given below duly technically vetted by Chief Engineer, J&K UEED. The General Abstract of each scheme is appended at Annexure 'A' and 'B' to this Govt. Order.

1	Construction of 6 MLD Sewerage Treatment Plant at Bypass Srinagar from Rawalpora to Tengpora	16.97
2	Constt. of Sewerage Scheme Zadibal	10.50

The accord of administrative approval is subject to the following conditions that:-

- i. The works are executed strictly as per the Codal provisions, Financial Rules, approved specifications and within budgetary allocation,
- ii. The AAA shall not be treated as an authorization to spend money which is not provided for in the budget and completion of these schemes shall be ensured during stipulated periods to avoid any revision,
- iii. All BIS/IRC/ASTM/CPWD codes/Manual/IRC specifications are followed while formulating the detailed estimates and design, specifications approved from the competent authority,
- iv. Release for balance work/amount shall be made in each case by the Administrative Secretary, HUDD based on physical/ financial progress and field verification thereof,
- v. That any such item/s not covered under relevant schedule of rates shall be paid in accordance with the set Codal procedures:
- vi. The NOC from other department needs to be obtained where ever required.



- vii. At the proper codal procedure, mandatory as per standing State Govt, Rules/ Regulations is followed for finalization of award of contract to entire transparency and economy,

The accord of administrative approval shall not however, be treated as an authority to:-

- a. Spend money not provided for, in the budget;
- b. Create new posts of any provided for in the Administrative Approval.



(Rawalpora to Tengpora Bridge) for Zone-1 of Greater Srinagar






