- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- iii. The TPQM agencies will undertake field visits for ascertaining quality of construction at various stages of construction as per

PMAY-U TPQM Reference Guide. Visits include examining/reviewing project documents and implementation and conducting any required tests/assessments and report writing. The Nodal Agency will report the progress of TPQM on a quarterly basis.

- iv. The Central Assistance for the purpose of TPQM will be limited to 3 visits to each project. The Nodal Agency is free to include more field visits by TPQMA, as necessary. For Central Assistance, the Nodal Agency will adopt an open and transparent procedure for procurement of these services.
- v. The detailed TPQM report of quality assurance will be scrutinized by the Nodal Agency and will implement all the remedial measures suggested by TPQMA. The Nodal Agency will place the TPQM report alongwith Action Taken Report before SLSMC, as per relevant formats under Reference Guide for TPQM.
- vi. the implementing agency shall transfer the funds through PFMS, as applicable and where there is an element of cash transfer to individual beneficiaries, the same may be made through PFMS/DBT mode as applicable;
- vii. the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GoI's prescribed guidelines;
- viii. the funds so released shall not be available for any reappropriation/ diversion at any level:
- ix. the expenditure shall commensurate with the physical progress achieved;
- x. the Utilization Certificate along with Red Accounts for the released amount shall be submitted to the Administrative Department/Accountant General Office, Jammu within the stipulated time;
- xi. The expenditure on the implementation of the scheme/projects will be shared between the Central and the State/ULB implementing agencies as approved by the CSMC, GoI.
- xii. The Nodal Agency shall utilize the grant in accordance with the approved guidelines of HFA(U) for the implementation of the
