The drawing & Disbursing Officer is required to observe the following instructions strictly;

- 1. The expenditure shall be made strictly in accordance to the classification under which funds have been authorized. No omissions/Commissions or diversion shall be made under any pretext unless specifically and separately authorized.
- There should be uniform expenditure under each object head to avoid rush of expenditure 2. during the last quarter of the financial year.
- The controlling officers shall be duty bound to ensure submission of revenue and 3. expenditure statements to this Department on monthly basis.
- The controlling Officers/DDOs shall conduct periodic reconciliation of remittances and drawls 4. with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
- 5. The Utilization certificate//Red Accounts of previous drawals be rendered to the concerned quarter without any delay.
- The controlling Officers shall strictly inspect and supervise the public receipts and 6. expenditure with reference to the Appropriation Act 2018 and all the standing rules and regulations.
