Subject:- Registration of case FIR No. 22/2018 P/S VOJ against Shri Raman Uppal, the then AEE Urban Local Bodies, Udhampur R/O 339. Shastri Nagar Jammu at present Executive Engineer, LAWDA, Srinagar- suspension thereof.

Whereas, the Director Vigilance Organization(now Anti Corruption Bureau) J&K vide communication No. VO-FIR-22/2018-J-12280-81 dated 9.8.2018, has intimated that on 20.7.2018 case FIR No. 22/2018 under section 5(1) (c) (d) of J&K PC Act Svt.2006, punishable u/s 5(2) P.C Act 2006 was registered by Police Station Vigilance Organization, Jammu, against Shri Raman Uppal, the then AEE Urban Local Bodies, Udhampur, for allegedly misappropriating Government money to the tune of Rs.50,10,846.00 and Rs.6.50 lacs (totalling to Rs.65,60,846/=) which were advanced to him for execution of development works in Municipal Committee Katra and Municipal Council, Udhampur


Whereas, Shri Raman Uppal the then AEE was transferred and posted in Lakes and Waterways Development Authority, Srinagar and before joining at his new place of posting i.e. LAWDA he neither rendered the accounts in respect of utilization equivalent to the said amount nor refund the temporary advance/imprest advance taken from Municipal Committee, Katra/Municipal Council, Udhampur, for which he did not render the accounts;

Whereas, the fact regarding failure of the officer to submit the account in full has been substantiated by the Director, Urban Local Bodies, Jammu vide communication No. DULBJ/297/11980 dated 16.10.2019

Whereas, the officer was served several notices directing him to adjust or refund the amount to the concerned Municipal Committees but the Officer failed to do the needful.

Whereas there are numerous complaints against the officer regarding his involvement in corrupt practices in allotment of plots to Dal Dwellers on selective basis as Executive Engineer, Lake Division-I LAWDA, which also needs thorough enquiry.

Whereas, Shri Raman Uppal the then AEE Local Bodies, Udhampur presently I/C Executive Engineer, LAWDA, Srinagar has failed to maintain absolute integrity and devotion to duty while discharging his official duty, as prescribed under Rule 3 of the Jammu and Kashmir Employees (Conduct) Rules,1971.



Now, therefore, keeping in view the above facts and circumstances, in terms of Rule 31 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, pending enquiry into his conduct, Shri Raman Uppal, I/C Executive Engineer, LAWDA, Srinagar, is hereby placed under suspension with immediate effect. During the suspension, the officer shall remain attached in Housing and Urban Development Department, Civil Secretariat, J&K, Jammu
