The Committee/Councils will in turn execute the works as per Action Plan Approved by the Competent Authority. The Commissioner, JMC will also execute the works as per Action Plan approved by the Competent Authority.

The above releases are subject to the following conditions:

1. The executing agencies shall provide to the H&UDD/Finance Department, the ULBs wise allocation of funds out of the instant authorization.
2. The executing agency shall send a status report the schemes, physical and financial progress during the current financial year, cumulative expenditure & physical achievements.
3. All codal formalities **and guidelines of 14th Finance Commission** should be strictly adhered while implementing the scheme.
4. Further funds shall be released only after schematic utilization certificates (UCs) are received in this Department for its onward transmission to GoI/Finance Department.
5. The executing agency shall ensure that there is no overlapping of funds for the works being executed from any other source/scheme.
6. The expenditure shall be booked as per the following classification.
