Sanction is hereby accorded to the Constitution of the Committee comprising the following, for facilitating of the Rehabilitation of the displaced Mule Owners operating between Katra and Shrine of Shri Mata Vaishno Devi Ji, in terms of the approved policy:

1. Deputy Commissioner, Reasi	Chairperson/ Chief Facilitation Officer
2. Additional Chief Executive Officer, Shri Mata Vaishno Devi Shrine Board.	Member
3. Sub-Divisional Magistrate, Katra.	Member
4. Chief Executive Officer, Municipal Committee, Katra.	Member

It is further ordered that:

1. A facilitation centre shall be opened in the office of the Deputy Commissioner, Reasi, who will be the Chief Facilitation Officer for the rehabilitation and empowerment of the displaced Mule Owners.
2. A single window shall be created at the facilitation centre to coordinate all issues relating to the rehabilitation of the displaced mule owners, including the issuance of licenses and getting necessary statutory permissions where ever and whenever required for establishing livelihood/ self-employment ventures.

3. The Committee shall meet as often as required and at least once a month and will submit reports to the Housing & Urban Dev. Department for appraisal of the Hon'ble Supreme Court;
4. Divisional Commissioner, Jammu shall review the functioning of the Committee at least once every quarter, and will submit reports to the Housing & Urban Dev. Department for appraisal of the Hon'ble Supreme Court;


