3. The released funds does not confer the sanction to incur the expenditure which shall be booked after observing all codal formalities;

4. The funds shall be utilized for implementation of scheme strictly as per originally approved components and according to Govt. of India's prescribed guidelines;
5. The Geo-tagging and conducting of Third Party Quality Monitoring funds shall be utilized after observing terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by the Ministry of Housing & Urban Affairs, Govt. of India.
6. The Progress Report about the scheme, in terms of physical and financial progress achieved during the current year and upto date cumulative expenditure and physical achievement be sent to this Department regularly;
7. Nodal Agency shall send UCs of the funds released as early as possible and defiantly well before 31.3.2020 to GoI with a copy to the Finance Department
8. The Nodal Agency shall vouchsafe the utilization of funds as per codal procedure/Govt. of India's guidelines.
