Sanction is hereby accorded to the release of funds to the extent of ₹490.00 lakhs (Rupees four crore ninety lakh only) under detailed head 028-GIA in favour of Vice Chairman, Lakes & Waterways Development Authority (LAWDA) raising the total allocation to ₹1027.50 lakh for meeting the expenditure on account of salary and others unit of appropriation for the financial year 2019-20.

The Director Finance, Housing & Urban Development Department shall draw the amount in advance from Civil Secretariat, Treasury through WDC bill by debit to MH – 2217 – UD Grant in Aid and placed the same at the disposal of Vice Chairman, LAWDA i.e; SB account No. 0229010200000004 – J&K Bank branch Brain Srinagar.

The Drawing & Disbursing Officer is required to observe the following instructions strictly;

1. The expenditure shall be made strictly in accordance to the classification under which funds have been authorized. No Omissions/Commissions or diversion shall be made under any pretext unless specifically and separately authorized.
2. There should be uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
3. The controlling officers shall be duty bound to ensure submission of revenue and expenditure statements to this Department on monthly basis.
4. DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
5. The Controlling Officers/DDO's shall conduct periodic reconciliation of remittances and drawals with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
6. The utilization certificates/Red Accounts of previous drawals have been rendered to the concerned quarter without any delay.
7. The Controlling Officers shall strictly inspect and supervise the public receipts and expenditure with reference to all the standing rules and regulations.
8. All the sanctions/approvals and clearances shall be in place before drawal of money from the Treasury.
9. This issues as per the authorization of Finance Department conveyed vide OM No. FD-VII-Bgt. (19) 2019-20 dated 01.08.2019
