**Government Order No: 191 - HUD of 2019**  
**Dated: 27 -09-2019**

Sanction is accorded to the release of funds to the tune of **Rs. 69.59 Lacs** (Rupees Sixty Nine Lakh and Fifty Nine thousand) only in favour of **Chief Engineer, J&K UEED, Srinagar** as an additionality under the scheme "Laying Sewerage Networks at Raj Bhawan, Jammu" (Capital Component) of State Capex Budget 2019-20 for its utilization during Current Financial Year.

- The release & subsequent utilization of funds is subject to the following conditions that:-
- i. The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
  - ii. The funds so released shall be utilized for specific purpose after observing all codal procedures/formalities including Administrative Approval and Technical Sanction by the Competent Authority;
  - iii. The implementing agency shall fulfil all codal formalities including e-tendering and ensure reasonability of rates before execution of the work;
  - iv. The reasonability of verifying the genuineness of claims and fulfilment of all codal formalities including audit, verification and on ground checking shall vest squarely with the implementing agency and shall ensure that the needful is done before releasing the payments;
  - v. The implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme including Languishing Project funded through JKIDFC or any other source;
  - vi. The funds so released shall not be available for any re-appropriation/diversion;
  - vii. The expenditure shall commensurate with the physical progress achieved;
  - viii. All video graphic/photographic evidence of works both shall be maintained;


