Sanction is hereby accorded to the release of **Rs.1841.00 lacs (Rupees One Thousand Eight Hundred Forty one lacs only )** as 2<sup>nd</sup> installment of Central Share ) for Construction of 60000 IHHL units under Swachh Bharat Mission (Urban) during 2019-20.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, Swachh Bharat Mission (Urban) bearing Account No. **0110040500000063** maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for further releases to implementing agencies.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;

- (v) the expenditure shall commensurate with the physical progress achieved;
- (vi) all video graphic/photographic evidence of works both shall be maintained.
- (vii) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2019 to GOI, with a copy to Finance Department.
