In continuation to Govt. Order No. 40-HUD of 2017 dated 22.02.2017, sanction is accorded to the release of funds amounting to **Rs. 1872.00 Lacs (Rupees Eighteen Crores & Seventy Two Lakh) only in favour of Superintending Engineer, Drainage circle, Srinagar Municipal Corporation (SMC)** under Prime Minister's Development Package (PMDP) 2015 for permanent restoration of damaged infrastructure for its further placement at the disposal of concerned Executive Engineer's to be utilized for clearance of work done liability occurred for restoration of flood damaged infrastructure of September 2014 / execution of works against approved action plan under permanent restoration of flood damaged infrastructure during current financial year 2018-19 as per the details given here under:

The release & subsequent utilization of funds is subject to the following conditions that;

- (i) the funds be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance of the Govt. order and copy endorsed to the Administrative Department;
- (ii) the funds so released shall be utilized only for specific purpose after observing all codal formalities including e-tendering, administrative approvals & technical sanctions from competent authority;
- (iii) the implementing agency shall ensure that in case any funds have been utilized in anticipation from other sources shall be recouped in first charge & debited their expenditure under permanent restoration of PMDP;
- (iv) the implementing agency shall ensure that works are taken-up and completed within approved cost. No work shall be tendered/allotted beyond the approved allocation;

- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
- (vi) the funds so released shall not be available for any re- appropriation/diversion at any level, besides no further liability be created and work shall be physically & financially completed within the approved cost;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.


