Subject:- Release of part third installment of Central assistance of Rs. 154.3520 crore to J&K State against SAAPs-I,II & III under AMRUT.

Sanction is hereby accorded to the release of **Rs.154.3520 Crore (Rupees One Hundred Fifty Four Crore Thirty Five lacs and Twenty Thousand only) only in favour of Mission Director AMRUT** towards the 3rd installment of the Central Assistance under AMRUT which is eligible amount against the last 40% of the committed Central Assistance as allocated under State Annual Action Plans (SAAPs I,II & III as project fund for implementation of projects under AMRUT during 2019-20.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, AMRUT bearing Account No. **0110040500000061** maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for further releases to implementing agencies.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii) the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- iii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- iv) the funds so released shall not be available for any re-appropriation/diversion;
- v) the expenditure shall commensurate with the physical progress achieved;
- vi) all video graphic/photographic evidence of works both shall be maintained.

- vii) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2020 to GOI, with a copy to Finance Department.


