Sanction is hereby accorded to the:

- I. Up-gradation of all Municipal Committees at District Headquarters and those with population more than 30,000 as per 2011 census, to Municipal Councils.
- II. Up-gradation of 13 Municipal Committees of District Headquarters as per **Annexure 'A'** to this order, as Municipal Councils, after following due procedure.
- III. Up-gradation of 13 (thirteen) posts of Executive Officers, in these Municipal Committees, in the pay Level-8, as Chief Executive Officers, in the Pay Level-11.
- IV. Filling up of the posts of Chief Executive Officers in the Municipal Councils initially by deputation from officers of Jammu and Kashmir Administrative Services (KAS) of an equivalent rank/scale.
- V. Creation of 19 (nineteen) posts of the Accounts Officers in the Pay Level-8 in all the 19 Municipal Councils in Urban Local Bodies Jammu/Kashmir and these posts to be filled up by deputation from Officers of the Jammu and Kashmir Accounts (Gazzeted) Services,.


