Subject: Re-instatement of Sh. Ashwani Kumar Kailoo, Junior Engineer, Urban Local Bodies, Jammu.

Government Order No: 69 -HUD of 2019
Dated: - 06 -03-2019

Whereas, Sh. Ashwani Kumar Kailoo, Junior Engineer, Urban Local Bodies, Jammu was placed under suspension vide Govt. Order No. 91-HUD of 2017 dated 29.03.2017 for executing sub-standard works in Billawar;

Whereas, the then Deputy Director, Urban Local Bodies, Jammu was appointed as Enquiry Officer to enquire into the matter and submit the report within a period of 15 days with specific recommendations;

Whereas, on the directions of the then Hon'ble Deputy Chief Minister, the then Additional Secretary to Government, Housing & Urban Development Department, Mr. Arvind Kotwal, alongwith Sh. S.K. Wali, Executive Engineer, Jammu Municipal Corporation conducted a physical check of 12 works executed by Municipal Committee, Basohli under different heads and submitted the report;

Whereas, it has been observed that some works executed have either average workmanship or have fair/poor workmanship;

Whereas, the matter was also taken up with Director Vigilance Organization for conducting enquiry in to the works at S. No. 6, 8 and 9 of the said report;

Whereas, Director, Urban Local Bodies, Jammu vide letter No. DULBJ/2018/16533 dated 16.02.2018 forwarded the enquiry report of the Inquiry Officer (Deputy Director, Urban Local Bodies, Jammu) who has concluded enquiry with the following recommendations :

“The allegations leveled against the said Junior Engineer is not based on facts and is recommended that the concerned official needs to be re-instated and the period of his suspension may kindly be treated as on duty.”

Whereas, Vigilance Organization, J&K (now Anti Corruption Bureau) vide communication No. ACB-Veri-JSK-83/2017-19833 dated

24.12.2018 also intimated that a verification was conducted by the Bureau with regard to works executed and nothing incriminating came to fore during verification. The matter stands consequently closed in the Bureau.

Now therefore, in view the recommendations of Inquiry Officer and report submitted by Anti-Corruption Bureau, Shri Ashwani Kumar Kailoo, Junior Engineer, Urban Local Bodies, Jammu placed under suspension vide Government Order No. 91-HUD of 2017 dated 29.03.2017 is hereby re-instated with immediate effect. The period of suspension w.e.f 29.03.2017 till issuance of this Government Order is treated as on duty.
